DEAR COMMUNITY OF GIVERS,

We made great progress in 2018. Our membership continues to grow and, collectively, with the additional support of a local foundation, we were able to award **six** transformational grants to nonprofits that serve our communities. As a member, you have made it possible for Impact 100 to pour more than \$4.69 million into impactful nonprofit initiatives that have improved lives in Greater Cincinnati, Northern Kentucky, and Eastern Indiana since 2001. We continue to fund nonprofits that impact these focus areas: Culture; Education; Family; Health and Wellness; and Environment, Preservation and Recreation.

Membership dues go directly toward funding grants, and, as a volunteer-run organization 100% of member contributions go directly to the nonprofits we support. In 2018, 478 members accounted for \$416,000 collectively invested in our community. In addition to renewing members like you, our 2018 grants were supported by a local foundation's generous donation of \$208,000. 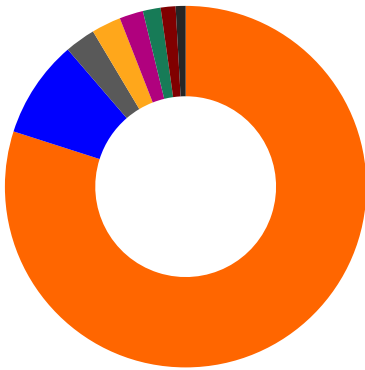

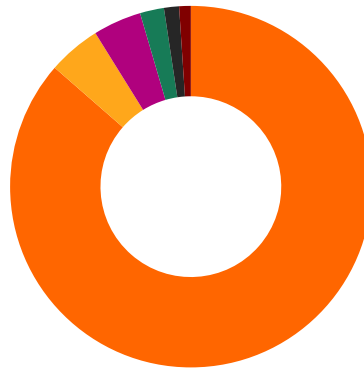

Impact 100 events are subsidized by our operating funds. Registration fees for the Annual Awards Celebration cover only 62% of the event costs, while the registration fees for all other special events cover 73% of those event costs.

Our endowment includes board-directed funds and donor-designated funds for the Young Philanthropist Program, thanks to the generous grant of \$100,000 to support young philanthropists by the Charlotte R. Schmidlapp Fund, Fifth Third Bank, Trustee.
